2. The Contestant must be single, never married, never had a marriage annulled and never had any children. The contestant must conduct herself in a fitting manner for a Queen per the Trimble County Fair Board rules.
3. Contestant must have reached her 13th birthday and can't have reached her 16th birthday by October 31, 2015.
4. Miss Teen Trimble County Fair will be open to Kentucky Residents.
5. Contestant will show in Theme Outfit and Formal Wear.
6. First place winner will be Miss Teen Trimble County Fair and represent Trimble County in the Miss Teen Ky. County Fair Contest. If for any reason she can not fulfill her obligations her and title will be revoked.
7. Miss Teen Trimble will have entry and hotel room paid for by the Trimble Co. Fair Board to the State Pageant in October. Miss Teen Trimble County must have a parent present with her, no boyfriends or others are allowed in her room.
8. All contestants must follow the rules set forth by pageant director. No one but your hairdresser is allowed in the building at time of pageant. Hairdressers must show proof of license and pay fair entry at the gate.
9. The winner of Miss Teen Trimble County Pageant may only hold one title until she competes at her Miss Teen Ky. State fair pageant in October. After State she may take part in other pageants. Titles won before winning Miss Teen Trimble County Fair can be held.
10. Miss Teen Trimble is to contact the pageant coordinator before taking part in any events or acts in which she is representing Miss Teen Trimble County. Miss Teen Trimble may be asked to take part in the Bedford Bash, Trimble County Apple Festival, Little Miss & Mister State Pageant in August, as well as other events.
And agree to participate in fair activities, as well as take part in the Madison Regatta Parade and float building. And the Trimble Co. Fair Parade. Failure to take part in all events may result in title revoked.
11. Where applicable and if for any reason a winner is arrested and found guilty of any illegal action they will Forfeit their title, any action that might need to be taken will be discussed by the Trimble County Fair Board
And their decision will be final.
12. Contestants must make a peoples choice box with number and pictures. And NO cell phone pageant day.
13. Trimble County Fair Board and all their employees, agents and servants cannot be held responsible for Accidents, injury or loss of personal property relating to this event. Judges' decisions are final.
